Let this checklist be a "to-do" list to get the year started right with your chapter house.

- 1. Schedule an inspection by the local Fire Marshal and correct any identified deficiencies.
- 2. Schedule an inspection by a local building code official and correct any identified deficiencies.
- 3. If the chapter house has a community kitchen, schedule an inspection by the local health department official and correct any identified deficiencies.
- 4. Ensure each member has signed an updated lease and paid their security deposit BEFORE allowing them to move-in.
- 5. Have each resident detail any issues with their room (i.e. holes in drywall, electric outlets not working, window issues, etc...).
- 6. Set up cable and internet. Check that internet equipment is updated and each resident room has access to high-speed internet.
- 7. Set up a meeting with the House Corporation to discuss budget, property insurance coverage, and any deficiencies identified in house inspections.

Taking time to take care of these seven items can save your chapter time and money later in the semester. So, with all the excitement of the beginning of another great year on campus, don't forget to get things started right with your chapter house by taking care of these important items!
