Facebook's Role in Risk Management

Many of us enjoy the benefits of being a member of Facebook. From keeping up-to-date on your friends' latest status updates to making sure you remember your chapter members' birthdays, we all use Facebook to some degree to keep our social life in order. Over the last several months, chapters are increasingly using Facebook to keep their social calendar in order too.

There have been several instances brought to the General Fraternity's attention of chapters creating Facebook event pages to market their social events. While we encourage chapters to take advantage of social networking opportunities, our members must be aware that Facebook invites are considered open social functions—a practice that could void the chapter's insurance coverage.

The Fraternity's <u>*Risk Reduction Policy and Guidelines*</u> prohibits chapters from hosting "open" parties. Each chapter social function where alcohol is legally present is to have a guest list that is pre-approved by the chapter. Also, the overall maximum guest-to-member ratio for these events is not to exceed 2:1. There are two primary reasons for this:

- 1. Guests who are not friends with any chapter members may not respect the rules the chapter has in place for the event and/or the venue at which the event is being held. They have no reason to keep the chapter's welfare in mind since they have no true connection to the chapter.
- 2. Based on past incidents, the Grand Chapter has determined that chapters are most able to maintain a safe environment and proper oversight at social functions when the number of present guests does not exceed 2 per chapter member. A social function exceeding this ratio has been deemed unsafe due to the inability a chapter may have in maintaining proper oversight and crowd control should a fight or other similar incident occur.

So talk with your Social Chairman and ensure that the next chapter social event doesn't make its way onto Facebook. After all, don't you have more fun with your friends rather than random strangers?

According to the <u>*Risk Reduction Policy and Guidelines*</u>, "Any chapter which fails to be represented at either Grand Chapter or College of Chapters shall not have alcohol on Chapter premises for the following academic year without the consent of the Office of the Executive Director."

Also, costs associated with participant materials and lodging has already been paid for via the conclave fee your chapter was assessed this academic year. The only thing the chapter has to pay for is the travel out to Boston and some meals. Ultimately, there is no reasonable argument for your chapter to not be represented at the 64th Grand Chapter.

So what can you do? Elect two delegates to attend, book plane tickets to Boston (if necessary), and sit back and wait for Grand Chapter 2010. Registration information will be coming out shortly. Also, keep checking the <u>Sigma Nu website</u> for the latest Grand Chapter information.
